## HALL TICKET INSTRUCTIONS TO CANDIDATES

1. This Hall Ticket is provisional and is no guarantee towards your entry into the examination. The Ticket is subject to cancellation, if it is detected subsequently that any information furnished in your application is incorrect or false.
2. You are required to report at the examination center at **8.30am** on the examination date.
3. At the entry gate you must produce Hall Ticket and Original Photo-ID as submitted in your original application form and indicated in the Hall Ticket. Any other Photo-ID shall not be accepted. You must paste [not to staple] a passport colour photo [same as annexed with application form] on the space provided in the Hall Ticket.
4. You must cooperate for frisking at the entry point.
5. **You will not be allowed entry if in possession of any forbidden articles like book, script, note, loose paper, calculator, pager, pen, pencil, watch, any written material, cell phone, communication/electronic device including any additional items declared as such by examination authorities.**
6. No candidate shall be allowed entry once the examination commences at 10am sharp.
7. A bell will ring at the start, at the end of each examination hour, before 10 minutes of finish time and at the finish time of the examination. The timing shall be as per the clock at the examination hall.
8. You must write your Roll Number at appropriate space [thirteen boxes] on the Test Booklet and OMR Answer Sheet. You are not allowed to write name or sign or put any other mark on the Test Booklet or OMR Answer Sheet.
9. You are to use the ball point pen supplied in the examination hall for writing basic data and marking answers by darkening the appropriate bubble. No other pen is allowed to be used.
10. You are required to sign on the Hall Ticket at the space provided as well as on the Attendance Sheet in the hall in presence of the Invigilator.
11. You must allow for frisking in the hall as and when asked for without any objection or resistance. You may also be required to produce the original photo I-card for verification in the hall if asked to do so.
12. Any kind of misbehaviour or non-compliance with the examination staff will render the candidature to be rejected with instant eviction from the examination hall.
13. Hall Ticket, Test Booklet, OMR Answer Sheet and Ball Point Pen - all these four articles must be submitted with the invigilator before leaving the examination hall. You are required to put your signature on the Exit Attendance Sheet before being allowed to leave the hall.
14. No candidate shall be allowed to leave the examination hall before the examination is declared to be over.
15. To answer a particular question you are required to darken the appropriate bubble in the OMR Answer Sheet with the supplied ball point pen. Incomplete darkening of bubbles, darkening of multiple bubbles or putting any other mark [tick /cross] to notify the answer or un-attempted questions shall be awarded 'zero' mark.
16. No candidate is allowed to cross talk, adopt any unfair means, cause any disturbance, impersonate anybody or obstruct/misbehave any official in the examination hall.
17. Smoking, having eatables or being in a state of intoxication in the hall is strictly prohibited.
18. You must abide by the instruction given in this Hall Ticket, OMR Answer Sheet and any further instructions conveyed by the examination authorities.

# INSTRUCTIONS FOR CANDIDATES FOR WRITTEN TEST

1. Do not open this Test Booklet unless you are asked to do so.
2. Before starting to attempt the questions ensure that no pages are missing or left blank or illegible so that it is brought to the notice of the invigilator.
3. Duration of Test is 3 hours. Total number of questions is 200. Maximum marks are 200. Each correct answer carries 1 mark. There shall be no negative marking for wrong answering or leaving a question unanswered.
4. You must follow all the instructions in the Test Booklet, in the Hall Ticket as well as any fresh ones issued by the hall invigilator or examination authorities.
5. You have to write your Roll Number [as in your Hall Ticket] on the space [thirteen boxed] in the Test Booklet as well as on the OMR Answer Sheet.
6. You must put your full signature on the Test Booklet, on the OMR Answer Sheet and on the Hall Ticket in front of the invigilator in the examination hall.
7. The invigilator shall also counter sign on the Hall Ticket and the OMR Answer Sheet at appropriate space.
8. You are not allowed to write /mark anything other than roll number and darkening of bubbles and a signature at desired space on any page of Test Booklets or the OMR Answer Sheet.
9. You have to mark the answer in the OMR sheet by darkening the appropriate bubbles marked A, B, C or D with the ball point pen provided to you in the examination hall.
10. No paper has been provided for rough work.
11. Use of any electronic or communication device is strictly forbidden.
12. The OMR Answer Sheet and Test Booklet must not be folded; no part of the two can be copied or detached in any circumstances.
