Eligible candidates are hereby notified to report at Walk-in Interview as per schedule with properly filled in application with all requisite enclosures as prescribed herein for the posts of **Senior Residents/Tutors** in the following disciplines at Veer Surendra Sai Institute of Medical Sciences & Research. The engagement shall be purely temporary and renewable on year to year basis for a maximum period of **three years** subject to satisfactory performance, conduct and age eligibility. The in-service candidates [regular service under state government] are entitled for their usual salary and a monthly Incentive @ Rs.20, 000/- for Tutors having MD/MS degree, @Rs. 15000/- for Tutors having MBBS/BDS degree and @ Rs.10,000/- for Senior Residents. Direct candidates are entitled for a contractual monthly remuneration of Rs. 65000/- besides monthly incentive @Rs.5000/- for Tutors with MBBS / BDS degree, @ Rs. 10,000 for Tutors with higher degree and none for Senior Residents. The posts are non-practicing.

1. **VACANCY:** The vacancy position below is tentative and subject to change on the basis of administrative exigencies at the discretion of the authorities. The appointment against the anticipatory vacancy shall be effective only after the date when the post actually falls vacant.

**Senior Residents:[48]**

**Anesthesiology [13], Pulmonary Medicine [2], ENT[1], Pediatrics[5], Orthopedics[5], Psychiatry [1], Dermatology [1], Radiodiagnosis [5], General Surgery -7 [General Surgery-6, Neurosurgery-1] General Medicine-8 [General Medicine-3, Cardiology-3, Neurology-1, Nephrology-1].**

2. **RESERVATION:**

The prevalent reservation policy of the state government will be applicable. In case of non availability of suitable candidates in any reserved category the same post will be filled up from the unreserved category.

3. **AGE :**

**Tutors:**

The candidate **must not be above 40 years** of age as on **1<sup>st</sup> January 2019**; the upper age limit will be relaxed up to 3 years for SEBC, 5 years in case of Women/ST/SC, and 10 years for Physically Challenged candidates. The same candidate cannot avail relaxation on more than one criteria simultaneously.

### **Senior Residents:**

The candidate must not be above 39 years of age as on 1<sup>st</sup> January 2019; there is no provision of age relaxation. The yearly extension of tenure of posting shall be for a maximum upto 40 years of age only.

#### **4. QUALIFICATION:**

- a. A candidate must possess a MD/MS/MDS degree in concerned discipline for Senior Resident post in clinical departments of broad specialties.
- b. In superspeciality departments (Neurosurgery/ Urology/Nephrology/Neurology/Cardiology) DM/MCh degree in concerned discipline is required to be eligible to apply for the post of Senior Resident failing which relevant MD/MS degree holders as per MCI rules will be considered. A candidate with one superspeciality degree will not be eligible for other superspeciality disciplines.
- c. In case of Pre/Paraclinical/Dentistry disciplines, MBBS/BDS is the basic qualification for the post of Tutor; however, preference will be given to MD/MS/MDS degree in concerned discipline.
- d. In case of non-availability of sufficient number of MBBS candidates, M.Sc. degree in Medical Anatomy/ Medical Physiology/ Medical Biochemistry/ Medical Pharmacology/ Medical Microbiology will be considered in respective discipline as prescribed by MCI.
- e. The cut-off date for the qualifications and other eligibility criteria [except age] shall be the date of counseling; No further extension will be as such allowed for production of deficient documents.
- f. If a candidate claims to possess any qualification equivalent to the prescribed qualification, the guiding rule/letter of authority must be furnished with the application form.

#### **5. OTHER ELIGIBILITY CONDITIONS:**

- a. The candidate must be a citizen of India.
- b. The Medical Graduates must have registered and updated their Medical Qualification at Central/State Medical Council.
- c. The candidate must not be continuing or have completed the tenure as Senior Resident/Tutor in any MCI recognized Institute.
- d. The candidate whose service as SR/Tutor has been terminated by any govt. medical college in the state for whatsoever reason will not be considered for re-appointment.

#### **6. APPLICATION FEE:**

For each discipline applied for, a candidate is required to pay a non-refundable and non-adjustable fee of **Rs.1000/- (Rupees one thousand only)** in shape of **Demand Draft** (signed at back by the candidate) to be drawn in favour of '**Dean, VIMSAR**' payable at '**SBI-Burla (SBIN-0002034)**'.

#### **7. DOCUMENTS TO BE PRESENTED: [Originals with one set of Self-attested photocopies]**

- 1) Application form as per format prescribed.
- 2) One passport size recent colour photograph signed by the candidate at front and pasted on the application form;
- 3) HSC/Equivalent Certificate in support of age;
- 4) +2/Equivalent Examination Certificate;
- 5) MBBS /BDS/M.Sc. Pass Certificate;
- 6) MD/MS/ MDS/ MCh/ /DM Pass Certificate;
- 7) Mark list of qualifying examinations including fail marks(as in clause 3, 4 and 5);
- 8) 'Chance Certificate' for all qualifying examinations(as in clause 3,4, 5 and 6);
- 9) Certificate of Internship Completion;
- 10) Updated Certificate of Registration for all Medical Qualifications at Medical Council;

- 11) Recent 'Service Certificate' from competent authority for Regular Govt. of Odisha employees;
- 12) 'No Objection Certificate' from non-state govt. employers/authorities (as per format enclosed);
- 13) Certificate from competent authority in support of Reservation; SEBC certificate must have been issued after March-31-2016.
- 14) Certificate of Permanent Residence /Nativity of Odisha issued on/after 01-march-2018. [applicable for candidates claiming reservation only]
- 15) DD towards application fees.

#### 8. METHOD OF SELECTION

- a) The candidate has to submit a **single application** form duly filled in even if he/she is applying for multiple disciplines;
- b) The selection of candidates for recruitment to the posts will be made on the basis of career assessment i.e. MBBS/BDS/M.Sc. (60%), Intermediate (20%) and HSC or equivalent (20%); One mark will be deducted from the accrued career mark for each case of failure / extra attempt taken in any qualifying examination.
- c) The application forms shall be scrutinized and a Provisional Merit List will be published.
- d) Counseling shall be conducted discipline wise as per schedule notified. Any candidate exercising an option for a particular discipline during the counseling shall not be considered for another discipline thereafter.
- e) The candidate has to appear personally at counseling failing which his/her claim will be forfeited.
- f) Candidate found eligible after document verification in a particular subject will be enlisted in a panel which will be duly approved by the selection committee.
- g) In case the appointed candidate to a post fails to join in time then only the next eligible candidate in the panel for the subject will be given a chance.
- h) Any subsequent counseling to select candidates from the panel will be a continuum of the previous counseling process.
- i) Any vacancy over and above those advertised will not be filled up from the list of empanelled candidates.
- j) The panel will be valid for a period of one year from the date of approval or till a period when the vacancy advertised are filled up or a fresh advertisement is floated for the discipline, whichever is earlier.
- k) All communications shall be made to the registered E-mail ID of the candidates; No postal communication will be issued.
- l) The decision of the selection committee is final.
- m) Any corollary or modification to this advertisement shall only be published in the institute website.
