Applications are invited from eligible candidates for **one** post of Radiotherapy Technologist in the Department of Radiotherapy at VIMSAR. Eligible and interested candidates are required to attend walk-in-interview in person scheduled on **Dt. 25.10.2021 [Monday] in METU Hall at 11 AM** along with the duly filled-in prescribed application form [attached herewith], all the required original documents and a set of self-attested photocopies of these documents.

The appointment will be for a period of one year which can be extended further subject to satisfactory work performance on year to year basis for a maximum period of four years or recruitment of a regular person to the post whichever is earlier. The posts are purely temporary and the candidates cannot claim their right to continue in the post on the basis of such appointment. They have to give an undertaking to this effect. In-service candidates have to produce **No Objection Certificate [NOC]** from the employer, failing which their candidature will not be considered.
