TERMS AND CONDITIONS OF THE TENDER CALL NOTICE

1. The tenderer should be a Registered Firm under GST.
2. The rates should be inclusive of all taxes except GST. The GST charges should be clearly mentioned.
3. The delivery & installation the system should be made in this Institution in good condition.
4. Any conditional Tender will not be accepted.
5. No advance payment will be made against execution of order. Payment will be released only after successful supply & satisfactory certification.
6. The rates should be valid for one year from the date of approval..
7. Original documents may be produced for verification if asked for.
8. If any information/documents furnished by the tenderers with the tender papers are found to be misleading or in correct, at any stage their tenders will be cancelled.
9. The Brand name of the items must be indicated in the tender. The selection may also be made by verification of samples. The tenderers will produce samples if asked for.
10. The products must be of good quality and also ISI/CE/BIS/ISO certified.
11. The selected firm is to enroll all the staffs of this Institution through Adhar Card Biometric System. The installation sites for Biometric will be intimated later on. The minimum requirement of the system is around 20 which may increase based on the decision of the Committee.
12. The selected firm has to make monthly visit regularly irrespective of status of the Bio Metric System. The firm has to mention the warranty period not less than two years.
13. The successful bidder have to deposit a sum of Rs.70,000/-(Rupees seventy thousand) only towards security deposit.
14. The Income Tax returns of last two financial years to be submitted with the tender documents.
15. The firm has to quote the CMC amount of the systems in their quoted rates separately.
16. One agreement is to be made with the selected firm for installation & subsequent maintenance of the system.
